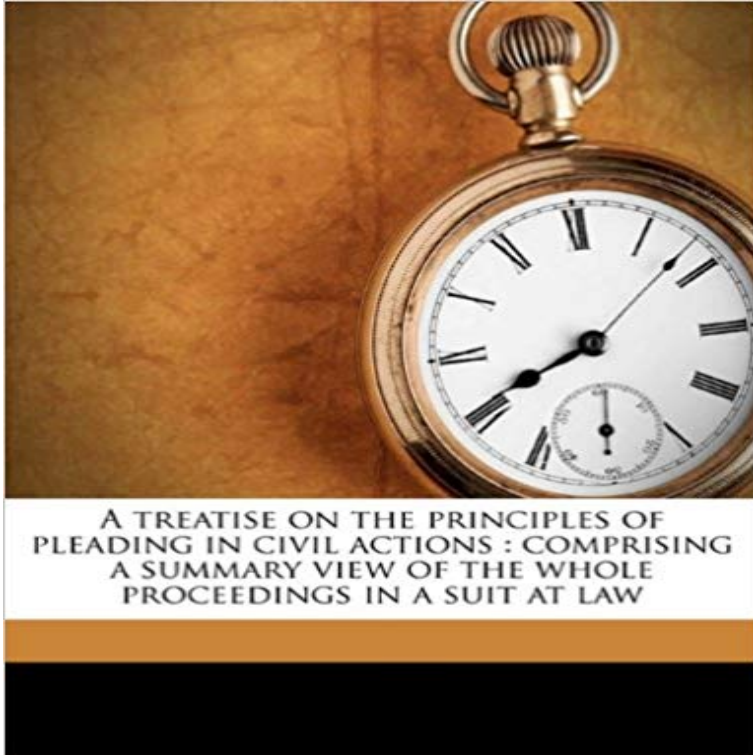


# A treatise on the principles of pleading in civil actions: comprising a summary view of the whole proceedings in a suit at law
