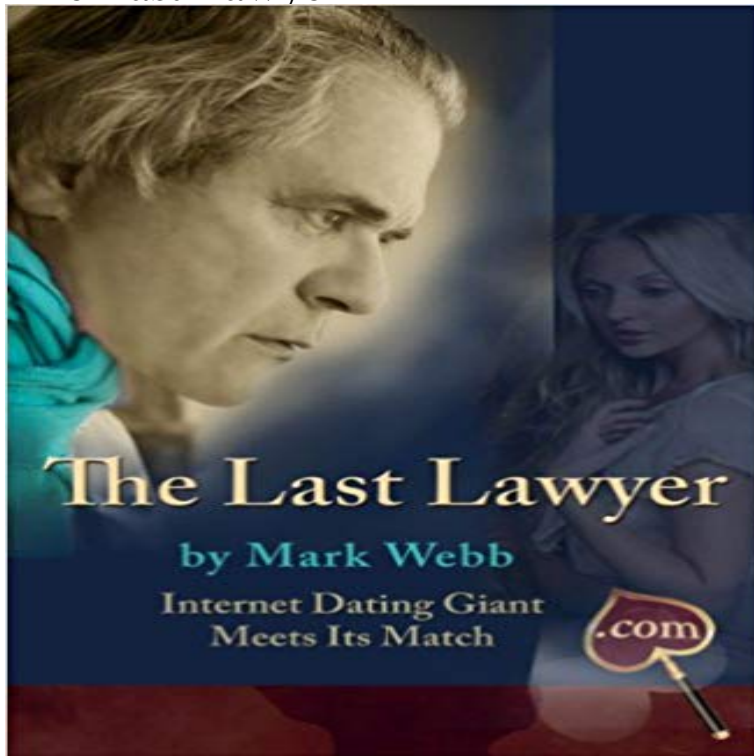


The Last Lawyer
