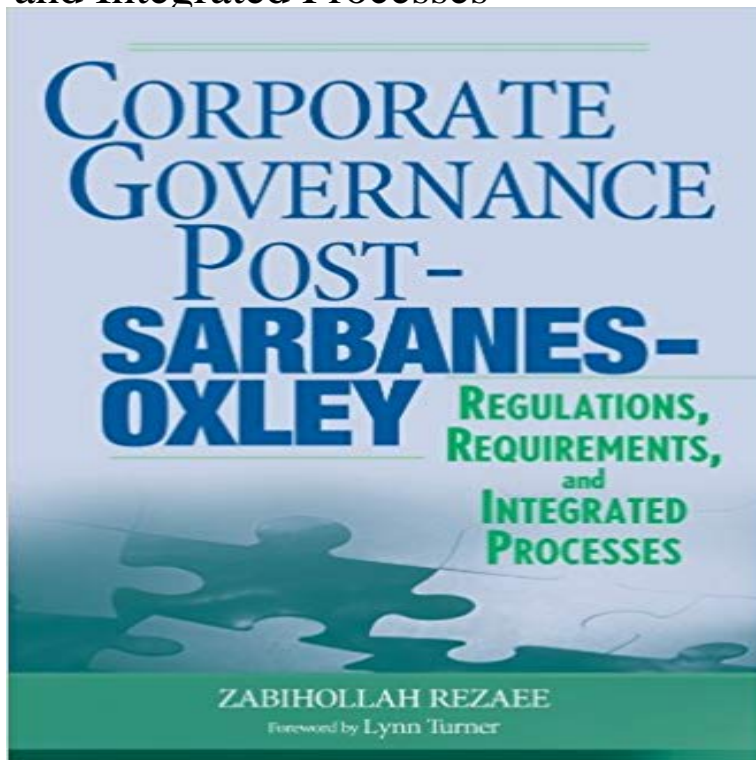


# Corporate Governance Post-Sarbanes-Oxley: Regulations, Requirements, and Integrated Processes
