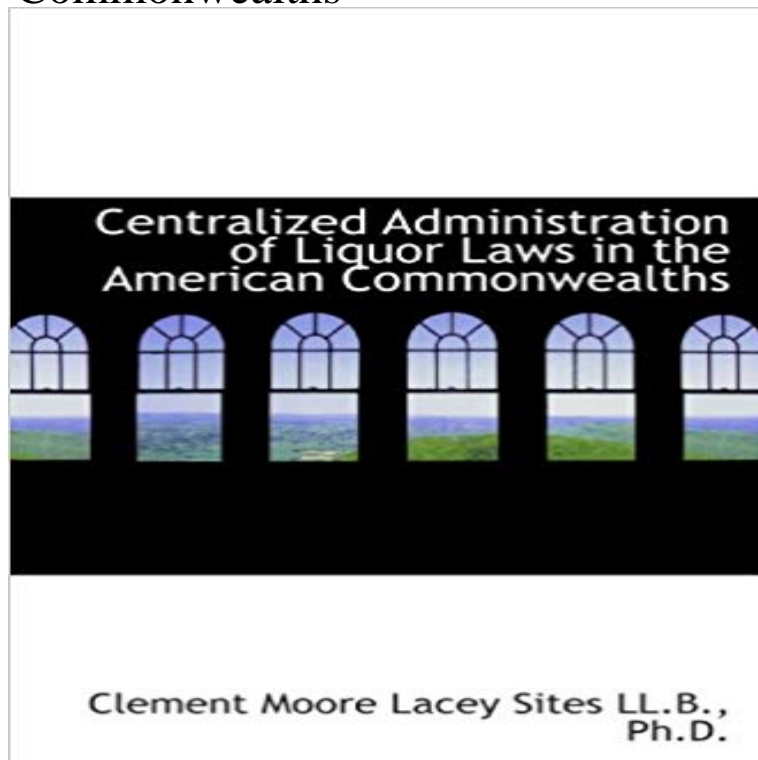


Centralized Administration of Liquor Laws in the American Commonwealths
