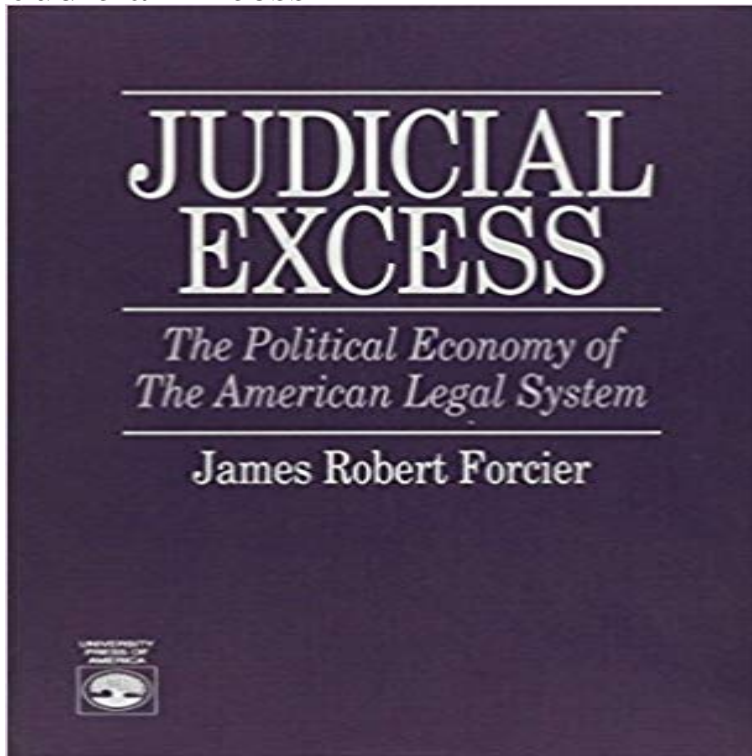


## Judicial Excess
