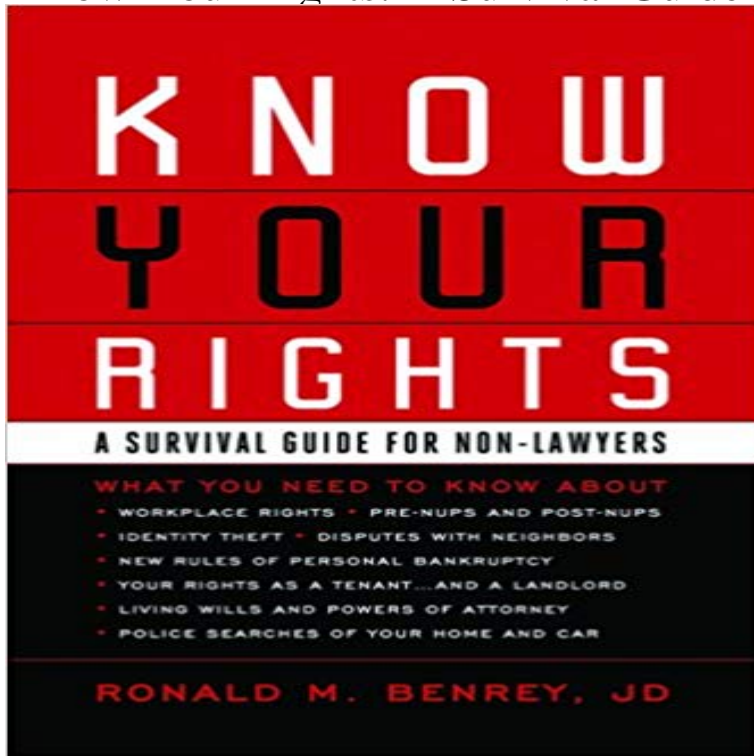


Know Your Rights: A Survival Guide for Non-Lawyers
