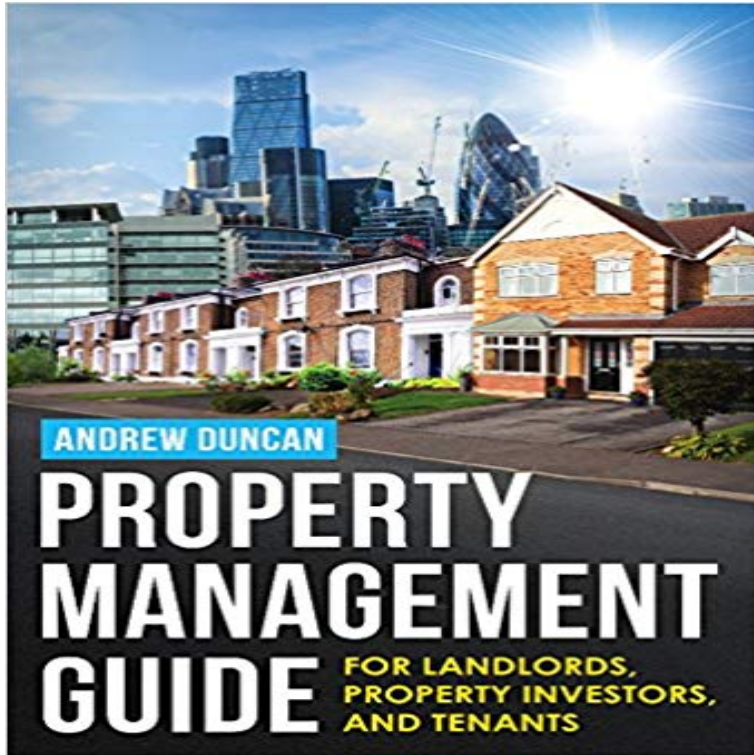


Property Management Guide: For Landlords, Property Investors And Tenants
