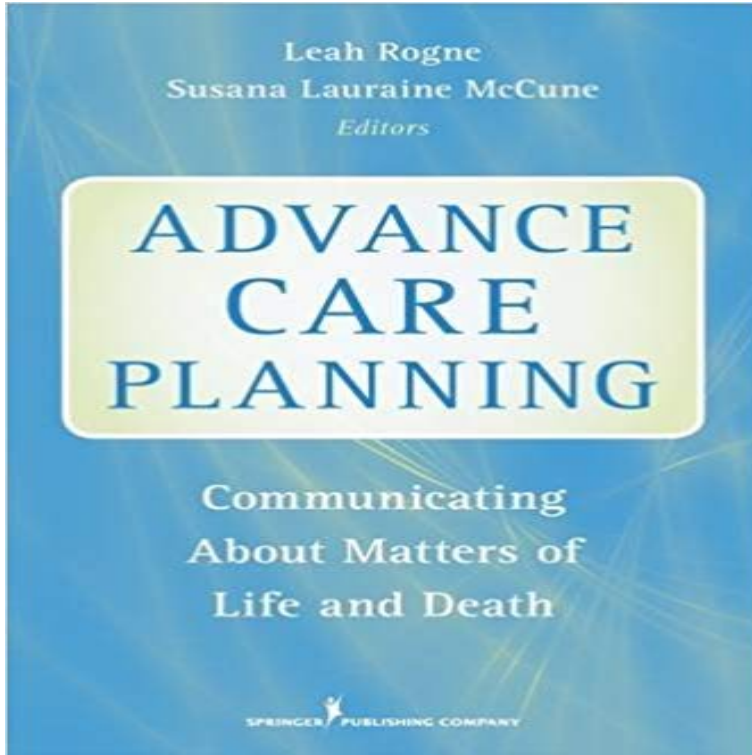


# Advance Care Planning: Communicating About Matters of Life and Death
